**Subject: Extension of the period of concurrent running of IS 9873 (Part 1):2019 and IS 9873 (Part 1):2025- “Safety of Toys Part 1 Safety Aspects Related to Mechanical and Physical Properties – Specification”.**

This has reference to the subject mentioned above.

IS 9873 (Part 1): 2019 was revised to IS 9873 (Part 1): 2025 with last date of implementation of the revised ISS as 23<sup>rd</sup> March, 2026.

The modification in the revised ISS includes location of warning which may requires manufacturers to revised their existing packaging labels and modification in the requirements of some varieties of toys.

In view of the above as licensees are likely to face difficulties for confirming to the revised ISS immediately, **the concurrent running of IS 9873 (Part 1):2019 and IS 9873 (Part 1):2025- “Safety of Toys Part 1 Safety Aspects Related to Mechanical and Physical Properties” has now been extended up to 22nd MARCH 2027.**

All BOs may bring it to the notice of all Licensees and Applicants.
